# Plymouth Borough Work Session and Rescheduled Regular Meeting November 19, 2017

The Plymouth Borough work session began at 1:00 P.M. and the regular meeting was immediately called to order by Mr. Gary Kochinski, President of Council.

#### CITIZEN'S REQUESTS AND COMMENTS REGARDING GENERAL ITEMS

Ms. Phyllis Scott, of 104 Girard Avenue, said she has lived in the borough since 1995. She knows about the property values and said that she is looking at the diagram with the data indicating the decline in values. She said that she understands the need to re-evaluate, to find ways to lower costs and the possibility of increasing taxes. She said mills could be increased by 20% and that it will not make any difference if property values continue to decrease. Mr. Kochinski agreed. Ms. Scott suggested aligning a grant from one of the foundations in the region and to work with a university that has an urban redevelopment or a public policy program and allow graduate students come in and examine what is going on to help stop the property values from decreasing any further. She said it's absurd that she looks in the newspaper and will see a house for sale in Wilkes-Barre that is in a neighborhood worse than her area and will see it go for forty thousand dollars more than her property.

Ms. Scott said the apartment complex on Center Avenue needs to be demolished. She said it has no roof and there has to be a way to get it demolished. She recommended not wasting any time with trying to find someone to buy the apartment building. Ms. Scott said while driving on her block she noticed that there was a house that wasn't actually a house and added that it did not have windows. Ms. Scott said there are property owners on her block who are trying to keep their properties up to date.

Ms. Scott offered her assistance and recommended working with outside sources that will not cost anything. She also suggested to find grant funds to cover expenses that might be incurred to help turn

the town around. She said she doesn't think anyone on this panel has a master's degree or PHD in public policies. Mr. Kochinski said that is why they have the solicitor attend the meetings. She said that he needs to have someone that is looking at what is going on. She added that Plymouth is not the only town that needs to be turned around. Ms. Scott said this is now her town and she would like it turned around because there are some beautiful houses and some people trying really hard. Mr. Kochinski asked Ms. Scott to leave her contact information with the Secretary and they will reach out to her.

Mrs. Mary Jarret of Center Avenue suggested someone attend the Housing Alliance Conference in Harrisburg which will be held the first week in December. Mr. Kochinski said they could look into who's schedule it could fit into. Mrs. Jarret said it is a well recommended convention. She said she was going to go and knows they are still accepting reservations. Mr. Kochinski asked if no one was able to attend from Council if she could attend and bring back the information. Mrs. Jarret said she would and that it was worth attending.
